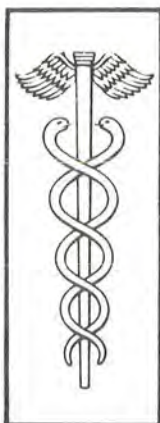
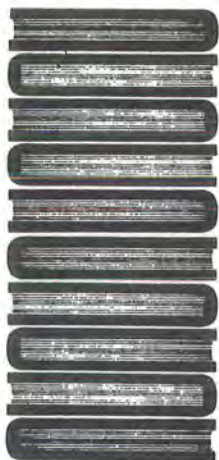

Can a record of library order information be used to predict and anticipate future publishing needs of libraries? These questions and ways in which libraries and publishers can work together will be explored.

"ABC: Automated Binding Control—a System for Easing Periodical Binding Preparation by Library Personnel"

Preparation of periodicals for binding is usually considered a chore. General Bookbinding, Chesterland, Ohio, has developed "ABC," automated binding control, a system which can cut bindery preparation time by one-third to one-half. ABC provides libraries with a complete file of computer preprinted forms for each volume to be bound that year. Each multi-part form, prepared from a master coding form

completed by the library, includes all information needed by both the library and the bindery, with only completion of variable information required.

"Automation Cuts Costs and Provides Better Subscription Service for Libraries"

Subscription service agencies act as communication clearinghouses between libraries and publishers. Both libraries and publishers input voluminous quantities of data which must be processed and output with uniformity and precision. Manual systems for handling subscription data require tedious, time-consuming repetition of clerical chores. Read-More Publications describes one approach to subscription agency computerization and the resulting benefits to libraries, publishers, and the agency.

"Mailing List Computerization"

Direct mail promotion is one of the most effective methods available to publishers for informing libraries and individuals about forthcoming and available publications. Information supplied by respondents is coded and fed into a computer. The selectivity permitted by a computerized data base allows mailings to specific scientific interests, geographic locations and account classifications; and eliminates the receipt of irrelevant material by potential purchasers.

Files of particular interest to health sciences libraries are Psychological Abstracts, Biological Abstracts, ERIC, NTIS, CA Condensates, INSPEC Science Abstracts, and NAL/CAIN. Dial-up and high speed terminals can access the service through a variety of communications networks including Tymshare, on a pay-by-usage, no minimum basis.

"SDC and Multiple Resources in On-Line Services"

The use of multiple resources in manual searches is now being translated into the use of multiple on-line systems and data bases. SDC

which provides a large number of data bases on-line including NTIS, CAIN, ERIC, POLLUTION, PMA/MEDLINE, PMA/MEDCOMP, CHEM7071, CHEMCON, SCISEARCH (life sciences), GEO—REF and others, has completed a study funded by the National Science Foundation on the impact of on-line services and multiple resource use.

"SDC and DIALOG—User's Point of View"

"The Development of a Library Minicomputer System"

The University of Minnesota Bio-Medical Library has developed an integrated system for library processing. Acquisitions and cataloging subsystems are in operation; serials check-in and control, accounting, and circulation are being implemented. The system, consisting of a minicomputer with video terminals and small printers in each library division, is completely under the library's control and operation. The system has been designed to be easily replicated in other libraries and will eventually provide for mutual access to the data files of each library using the system.

"The UCLA Biomedical Library Processing System"

The processing system used at the UCLA Biomedical Library has its origins in the batch mode serials control system developed in the 1960's. The present system includes an on-line serials system with modules for check-in, updating and retrieval, claims, bindery preparation, and accounting; and a computer-assisted cataloging and card production system. The addition of an acquisitions subsystem integrating features of both existing subsystems is being considered. Cost benefits and network capabilities of the system are discussed.

*"The Development and Operation of the Ohio College
Library Center"*

The Ohio College Library Center is an on-line computerized network providing access to one and a quarter million machine-readable MARC cataloging records and four million locations listings constituting an on-line union catalog. The objectives of the system are to increase the availability of resources to 400 participating libraries and to decelerate the rate of per-unit processing costs. OCLC is currently implementing an on-line serials control module; acquisitions, inter-library loan, circulation subsystems and subject access to the on-line catalog are under development.

*"Use of Proprietary Software in the Automation of Technical
Services Activities"*

In 1973, the National Library of Medicine began experimenting with a data base management system marketed by Infodata Systems, Inc. The software package has been implemented in major program areas of the Library, including acquisitions, serials, indexing, interlibrary loan, extramural programs, and the National Medical Audiovisual Center. The effectiveness of proprietary software packages is evaluated and results demonstrate that libraries can avoid the high costs of systems development and programming by using proprietary software packages.

BIBNET, an on-line bibliographic data base that includes 1,250,000 items cataloged by the Library of Congress over the past five years, is available via the nationwide Tymnet system. This paper describes the on-line service modules now available including 1) the Reference Module providing in-depth subject search, holder codes and call numbers, and message handling for interlibrary loan use; and 2) the Cataloging Module providing on-site automated text-editing and production of catalog card sets. Data base coverage in both general and specialized subjects as well as user-training and pricing will be described in detail.

The Twin Cities Biomedical Consortium was organized to improve local horizontal cooperation. A viable network of over twenty-five

health science libraries from a variety of institutions resulted, with cooperative programs designed to provide a more efficient method of document delivery, coordination of costly monograph and serial purchases, and exploration of other library services amenable to cooperative planning. The key to success of the TCBC is cooperation between librarians, philosophical and financial commitment, and flexibility in project participation.

It became operational on January 1, 1974 and has been jointly financed by the Pierce County Medical Society and the eight hospitals of Pierce County. Comprehensive library services are extended to the professional staff and allied health personnel in support of quality patient care, research, continuing medical education programs and in-service training.

Faced with the prospect of restricting interlibrary loan service or imposing fees, six community hospitals entered an informal agreement to share resources. All have been accomplished through group cohesiveness and commitment within each library's existing budget and without additional funding.

"The Diffusion of Information Innovations in Health Sciences Libraries"

A research study designed to measure the relationship between exposure to information about MEDLARS Demand Search Service and subsequent use of the service is described. The value of creating a suitable interface between information systems and their potential users is discussed, as is the role of a "change agent" in providing sufficient information about new information systems to potential users. The relevance of the case study results is indicated for other health sciences librarians.

"Medical Socioeconomic Research Sources: an On-Line Retrieval System for the Sociology and Economics of Medicine"

Publications in the sociology and economics of medicine have doubled in volume over the period 1962-74. To provide access to this rapidly growing field, an on-line information system was devised with inputting, data processing and editing managed from a terminal in the AMA Library. From this system, both published products and on-line retrieval services are generated. The procedures are generalizable to other areas of science and technology.

"An Experiment in Teaching MEDLINE"

The design and implementation of an experimental MEDLINE training module at Case Western Reserve University School of Library Science is described. The module places MEDLINE within the context of multiple data bases and networking operations, and is embedded in a course in Health Science Communications. The module consists of eight weeks of lectures, demonstrations, videotapes and exercises on the terminals. Thirty students are being trained as MEDLINE analysts.

"Some Automated Techniques of Information Retrieval in Family Planning and Population Libraries"

Two automated information retrieval systems for population and family planning are described: (1) The Carolina Population Institute has an off-line system which searches a data base drawn from its library holdings; (2) POPINFORM, coordinated by George Washington University's Population Information Program and developed by Informatics, Inc. is an on-line system containing a number of data bases from both university and government organizations.

*"Does Computer-Based Instruction Belong in the Health
Sciences Library?"*

Computer-based instruction is gaining acceptance in the health sciences where hourly costs of conventional instruction are already high. Placing terminals in health sciences libraries provides periods of unsupervised access and is consistent with the concept of the library as a learning resource center. However, costs for training library personnel, space and equipment are incurred, and new problems arise in cataloging and maintenance. The library administration should participate in planning educational programs to help create an awareness of the advantages of the library as a potential terminal site.

George L. Hody, University of Illinois School of Basic
Medical Sciences at Urbana/Champaign, Urban, Illinois
*"PLATO Computer-Based Instruction in the Health
Sciences"*

The PLATO IV system is a University of Illinois project in developing highly efficient computer-based techniques for education. It supports over 900 terminals in the U.S., Canada and experimentally in Europe. These are connected to a central computer facility by standard phone lines. Any student user can access over 3,000 courseware modules. All terminals have full graphics capability, project microfiche and respond to either touch or keyboard input. Programs are compiled and executed within seconds of being written. Health science lessons are currently developed in six institutions and used in twelve.

Twyla Bishop, Medical College of Georgia, Augusta, Georgia
*"A Computer-Assisted Instruction Program Developed at the
Medical College of Georgia"*

The Medical College of Georgia has developed its own computer-assisted instruction (CAI) program. Fourteen basic banks have been created and are utilized and maintained in-house. The philosophy of a self-developed program in terms of cost, personnel utilization, departmental organization and the existence of the Lister Hill program is presented. As student enthusiasm was responsible for the growth of

the system, users were surveyed for school affiliation, programs used and time spent at the terminals. Usage has grown from 50 users per quarter three years ago to a minimum of 340 users per month.

"On-Line Searching of the BIOSIS Data Base"

Biosciences Information Service of Biological Abstracts (BIOSIS) produces a machine-readable data base which has been leased for batch searching and soon will be available on-line. The data base content and characteristics, and the BA PREVIEWS magnetic tape service will be described. Studies conducted by BIOSIS to evaluate on-line searching of the PREVIEWS file will be reviewed and the experimental results, particularly related to training and the use of search tools, will be discussed.

Molly Wolfe, Informatics Inc., Rockville, Maryland

"Excerpta Medica On-Line Service"

A description of the new Excerpta Medica On-Line Service will be presented. A steering Committee composed of industry, government agencies, and research organizations participated in defining the services during a two-month trial access to the data base. The results of this trial evaluation, the present status, and future plans will be discussed. Responsibilities of the various system components to provide on-line access to a large-scale data base are identified, including the role and responsibilities of the user community.

"SUNY Biomedical Communication Network"

The SUNY Biomedical Communication Network, in operation since 1968, is an on-line bibliographic retrieval system which provides literature resources to thirty-five participating institutions. The Network offers these data bases: MEDLARS, including International Nursing Index and Index to Dental Literature; Psychological Abstracts; and ERIC. With completion of an experimental project in June, the Network plans to make another data base, Biological Abstracts, available.

"Cooperative Acquisitions and the Other Side of the Coin"

A pilot project applied to a single facet of the acquisitions operation is described. Fourteen libraries, linked geographically and through a cooperative center, have volunteered to coordinate management of their serials collections in order to prevent erosion of regional resources in the face of rising costs. Both cancellation of subscriptions and acquisition of new titles are considered, and the libraries establish responsibility for title maintenance. Philosophical aspects of the undertaking are also discussed.

Paul E. Olson, The John Crerar Library, Chicago, Illinois

"Analysis of the Midwest Medical Union

Catalog—Alternatives for Location of Monographs in a Network"

An extensive cost-benefit analysis of the Midwest Medical Union Catalog of books studied the 49-year old catalog in the context of interlibrary loan activity of the Midwest Health Science Library Network, and tested it against other location methods and against the alternative of using a large backup library (NLM) instead of routing requests through the network. It was recommended that the catalog be maintained at a minimal level until computerized data bases of monograph titles provide equivalent locational probability.

"The IBM Magnetic Card Selectric Typewriter and the Simultaneous Production of Catalog Cards at the Westchester Medical Center Library"

A cost analysis study was undertaken to determine how in-library production of catalog cards using the Mag card typewriter system compared with purchased cards in reclassifying a medium-sized medical collection from LC to NLM. A break-even point is determined using the derived figures, and a centralized cataloging center is proposed to make this operation an optimal one.

Cynthia K. Robinson, University of Texas Health Science
Center, San Antonio, Texas

"The Use of the MARCIVE Library System by the University of Texas Health Science Center at San Antonio"

The University of Texas Health Science Center Library has been using the MARCIVE computer cataloging system for four years.

Cataloging data for monographs, audiovisuals, and faculty publications is keypunched and stored in MARCIVE format on disc and tape. From this data catalog cards, acquisitions lists, book catalogs, and selected bibliographies can be generated. Time and cost studies show MARCIVE to be competitive with other card production methods including UCLA's computer system, OCLC, minigraph, and commercial cards.

*Diane Hawkins, Mt. Sinai Medical Center, Miami Beach, Florida

"Developing a Computer Produced Book Catalog for Use in a Medical Center Complex"

A paper presented earlier today described the decision-making and evaluation of a project to produce a book catalog for the Mt. Sinai Medical Center by Science Press. Now the details of producing catalog proofs, reclassifying and recataloging according to NLM are described. Communication between the library staff and Science Press was vital and a good understanding of the computer program was essential to visualize the effect of each decision on the printed page of the book catalog.

"The OCLC On-Line Cataloging System"

The on-line shared cataloging system at the Ohio College Library Center (OCLC) enables searching of a large cataloging data base built by MARC tapes and shared cataloging of OCLC's member libraries. The on-line cataloging permits modification of available cataloging data, original cataloging and tailoring of card production to meet the member library's needs. The system can also provide pre-order bibliographic verification, physical labeling of the book, ILL information and collection development information.

Josephine Yeoh, Riverside Methodist Hospital, Columbus, Ohio

"Use of the OCLC System in a Small Medical Library"

An Ohio College Library Center cataloging computer terminal was installed in the medical library of an 850-bed hospital, the only hospital library in the country to have one. Costs are discussed as well as problems encountered; and recommendations are made for other hospitals considering OCLC membership.

"MEDLARS II Cataloging"

Under the MEDLARS II system, the National Library of Medicine supports two on-line data bases for cataloging: 1) CATLINE contains NLM cooperative cataloging for monographs and serials since 1965; 2) the Name Authority File (NAF) includes all cross references and histories for all names used in NLM's descriptive cataloging. Under MEDLARS II, CATLINE records can be converted to LC's MARC II Format, making the NLM data base potentially available through other cataloging networks such as OCLC.

"Implementing an On-Line Serials Control System"

The Medical Sciences Library and the teaching hospital library at the University of California at Irvine acquired an on-line serials control system quickly and at low cost by entering a consortia with the UCLA Biomedical Library. The conversion was funded by an NLM grant and carried out mainly by the existing serials staff at Irvine. The main implementation problems dealt with staffing arrangements and entry accuracy. Most impressive of the new system is the ease of claiming and updating records. Public needs are met largely with printed lists which are updated every two days.

Virginia H. Bowden, University of Texas Health Science Center, San Antonio, Texas

"The PHILSOM System: One User's Experience"

PHILSOM, the automated serials system developed by the Washington University School of Medicine, now serves thirteen medical libraries. The University of Texas Health Science Center at San Antonio library has participated in the PHILSOM system since 1972. The multiple printed listings produced by the system have been a major benefit; more than half of the serials and related questions formerly referred to reference librarians are now being answered directly by users. Operating costs and the effect of PHILSOM on check-in, claiming, and personnel are also discussed.

Spencer S. Marsh, The Medical Library Center of New York, New York, New York

"PHILSOM—the Move East"

In 1973 the Medical Library Center of New York acquired the programs and data base of the PHILSOM system to establish a shared cost serials control system for medical and hospital libraries in the New York Metropolitan Area. Discussed in the paper are the experiences in developing the operating system for New York and the adaptation of the programs and data base for this environment. A cost and operational analysis for the first eighteen months of the network are included.

Meg Sarver, Ohio College Library Center, Columbus, Ohio

"OCLC's On-Line Serials Processing"

The Ohio College Library Center will automate serials processing in two distinct but interrelated subsystems: (1) The OCLC shared Cataloging Subsystem, designed to maximize resource sharing through shared cataloging, MARC, CONSER, and other machine readable files without sacrificing local options, will be used for serials cataloging; (2) The Serials Control Subsystem containing the "local data record" will automate check-in, claiming and bindery processing. Cost is dependent on the number and type of transactions; no extra charges are made for equipment.

"SERLINE"

Designed to assist network, I.I. and cooperative acquisitions activities SERLINE is available to the network for on-line searching under the ELHILL Program and is edited and maintained at NLM on INQUIRE, a software package with extensive editing and report generation capabilities. Over the past year, MEDLARS II implementation has prevented regular transfer of data from the updated INQUIRE file to the ELHILL network file, but hard copy products from the INQUIRE file have been distributed throughout the network.

"CONSER and the National Serials Data Program"

CONSER, a cooperative effort to build a core machine readable data base of bibliographic information for serials, will be useful in developing serials systems in libraries and in providing a base file for the International Serials Data System and the National Serials Data Program (NSDP). It is being built using the facilities of the OCLC and involves the participation of the three national libraries and the National Serials Data Program, the National Library of Canada, and some large research libraries.

"A Computer Generated Audiovisuals Catalog"

Six problems of retrieving audiovisual items are presented to describe how a computer generated audiovisual catalog developed at the Eccles Medical Sciences Library addresses each of the problems. Briefly, the Media Services Catalog lists one complete entry for each item by media format with access by title, MeSH subject headings, and gross categories. The reasons for this arrangement are described. The catalog is proposed as a basis for an AV union list for health institutions in the Salt Lake City area.

"MEDOC: A Computerized Index to U.S. Government
Medical Documents"

In order to aid retrieval of U.S. Government health documents, Eccles Medical Sciences Library at the University of Utah developed a computed produced index—MEDOC (medical documents). MEDOC provides access by Superintendent of Documents Classification, title, subject and series number. A seven-year cumulation, January 1968-December 1974, recently produced, will be supplemented by quarterly updates and annual cumulations. MEDOC, available on subscription basis, will be useful to medical libraries for locating, acquiring, and cataloging government publications.

Hiroko Kawashima and Shinako Honda, National Cancer Library, Tokyo, Japan

"Computer Application for Housekeeping in a Small Medical Library—a Case at the National Cancer Center Library"

The National Cancer Center Library, a small medical library containing 8,200 monographs and receiving 790 current journal titles, recently started using a computer for two housekeeping tasks: 1) compilation of loan record statistics, and 2) lists of journal holdings. These programs were operated using the computer installed by the parent institution, the National Cancer Center (Japan) and shared with other departments of that institution. The systems were designed and operated by the library staff.

Soo Lee, Peggy Gratz, and Joseph White, Bowman Gray School of Medicine, Winston-Salem, North Carolina

"Computer-Stored Faculty Publication File Using MT/ST in a Medium-Sized Medical Center Library"

The Bowman Gray School of Medicine Library computerized a faculty publication file by adapting an existing system that utilized a Magnetic Tape/Selectric Typewriter for cataloging. This file has provided print-outs for the School's annual report and monthly faculty bulletin. When the file is finished, complete author and departmental listings can be retrieved. The file will be continuously updated by adding current citations and new faculty bibliographies and by deleting data when faculty leave the staff.

Esther R. Meiboom, Martland Hospital Library, College of Medicine and Dentistry of New Jersey, Newark, New Jersey

"Conversion of the Periodical Collection into Microfilm Format in a Teaching Hospital Library"

The Martland Hospital Library converted periodical backfiles into 16mm microfilm cartridges. Details of implementation, user reactions, costs and problems are discussed. The principal conclusion is that microfilm in cartridges is well accepted by patrons, provided that the need for reading from a projection screen is minimized by the availability of liberal printing privileges.

Jean Kerr Schwank, Community Hospital of Indianapolis, Inc., Indianapolis, Indiana

"Mock KWOC: a Computerized Checklist of Hospital Departmental Holdings"

A title-derived computerized checklist has been developed by the library at the Community Hospital of Indianapolis to provide partial bibliographical control over departmental holdings. The four-part print-out lists books by author, title, keywords, and department in a keyword-out-of-context format. Unit cost to input data is forty-five cents. The system is not designed to replace cataloging but may be a practical alternative when cataloging is not necessary or possible.
