If the door is cool, take your key, open the door slowly, and proceed to the nearest exit (crawl if the hall is filled with heavy smoke). Do not use the elevators. If the door is hot, do not exit your room. Seal the cracks with wet towels, phone for help, and wait.

Journal Pricing: Causes, Effects, Solutions

A continuing rise in journal prices has precipitated a budget crisis for many health sciences libraries. Annual double-digit price increases for subscriptions in the face of government indicators that suggest marginal economic growth and low inflation rates are now the rule rather than the easily understood exception. Proliferation of journals constitutes another stress on collection development budgets. Clearly forces are at work that need to be articulated and understood in terms of systems before solutions can be designed that will reach beyond the realm of any single part of the publishing enterprise. A panel of speakers from key segments of the biomedical publishing industry will present their perspectives on the engines driving the cost and proliferation of journals, the effects of these forces, and what may be done singly and collectively to meet the challenge of maintaining a vibrant system of scholarly exchange now and in the future. It is the intent of the program organizers that this forum serve as a prelude to a broad, long-term dialog among appropriate representative agencies that will lead to strategies designed to influence the cost and value of the biomedical literature.

The information explosion has never been felt more, perhaps, in any field than in the biomedical sciences. Management of dental literature in basic, clinical, and epidemiological sciences has become intractable by traditional methods. It is important that dental librarians get involved with other information scientists in making use of the technology. Moreover, it is critical that the availability of technical

HEALTHFAX: An Experimental Telefacsimile Network in Ohio

Moderator: Lawrence W. Onsager, Library Director, Kirksville College of Osteopathic Medicine, Kirksville, Missouri

In June 1986, a one-year pilot project called HEALTHFAX was initiated in Ohio. The project's purpose was to establish the feasibility of providing biomedical information and documents from major health sciences libraries to small, medium, or remote libraries via telefacsimile. The State Library of Ohio funded the project with a Library Service and Construction Act (LSCA) Title II grant of \$71,649. Two of the seven academic health sciences libraries in Ohio were chosen as hubs with others in support. The hubs were designed to service public, hospital, small academic, and institutional libraries. Seventeen libraries were equipped with telefax machines, and the hub libraries provided the education, training, and logistical support for the participants. Criteria used to determine the success of the project were: 1) number of reference questions asked, 2) number of ILL requests filled, 3) number of pages transmitted, and 4) response to 75% of requests within twenty-four hours. While the number of reference questions anticipated proved to be too high, the use of the system far exceeded what was expected. An average turnaround time of twenty-four hours was unrealistic; forty-eight hours was normal. The project met expectations, and it was agreed that the network should be continued.

The development and use of pharmaceutical products depend heavily on the adequacy and completeness with which information on drug safety, efficiency, and costs is collected and disseminated. Unfortunately, major deficiencies exist in this regard. These deficiencies include the limited availability to interested parties of data collected by industry and federal regulatory agencies (both U.S. and foreign) and by the World Health Organization, inadequate indexing of published literature, failure to retrieve information from older publications, deficiencies in journal article composition and editing (e.g., regarding statistics), questionably relevant data on animal toxicity, pharmacokinetics and drug interactions, lack of "naturalistic" epidemiologic data on cost/benefit assessments, preoccupation with group rather than individual responses to drugs, and the failure of regulatory agencies to keep drug labeling up-to-date.
